# Phoenicia Library Board of Trustees Minutes from Library Board Meeting on April 20, 2023 Minutes prepared by Holly George-Warren

**Present:** Holly George-Warren, Bethia Waterman, & Bernard Handzel Elizabeth Potter, Library Director; Manuela Jean-Pierre, community member.

Motion to approve agenda by made by Bernie, seconded by Holly; all in favor.

Motion to approve the minutes from March meeting by Bernie, seconded by Bethia. All in favor.

ACTION ITEM: Bernard Handzel made a motion to approve the Tax Cap Override Resolution, Holly 2<sup>nd</sup>, all in favor, as follows:

Whereas, the adoption of the 2024 budget for the Phoenicia Library may require a tax levy increase that exceeds the tax cap imposed by state law as outlined in General Municipal Law Section 3-c adopted in 2011; and

Whereas, General Municipal Law Section 3-c expressly permits the library board to override the tax levy limit by a resolution approved by a vote of sixty percent of qualified board members; now therefore be it

Resolved, that the Board of Trustees of the Phoenicia Library voted and approved to exceed the tax levy limit for 2024 by at least the sixty percent of the board of trustees as required by state law on April 20th<sup>th</sup>, 2023.

Voting: All in favor of the resolution: 3 (of 5) members of the Phoenicia Library Board present at meeting: Bernard Handzel, Holly George-Warren, Bethia Waterman.

ACTION ITEM: Bernard made a motion to approve a Petition for the Town of Shandaken 414 support of the Phoenicia Library to be placed upon the ballot and voted on at the next general election of the TOWN OF SHANDAKEN on November 7, 2023, as follows:

- SHALL THE TOWN OF SHANDAKEN INCREASE ITS ANNUAL CONTRIBUTION FOR THE
- OPERATING BUDGET OF THE PHOENICIA LIBRARY BY SEVENTEEN THOUSAND SEVEN HUNDRED FIFTY (\$17,750) DOLLARS TO THE SUM OF ONE HUNDRED NINETY-NINE THOUSAND SEVEN HUNDRED FIFTY (\$199,750) DOLLARS ANNUALLY?

Bethia 2<sup>nd</sup>, all in favor.
